Part of this loan will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

The **Kolkata Municipal Corporation** (“the Employer”) represented by the Project Director, Kolkata Municipal Corporation - Sustainability, Hygiene And Resilience Project (KMC-SHARP), invites eligible bidders to submit bids online in the e-Tendering platform of the State Government of West Bengal (URL: <https://wbtenders.gov.in>) for the — Development of S&D Network in Adjoining Area of Jadav Ghosh Road in Suti sub basin in Borough XIV & XVI (Part of Ward 126 & 127) including Construction of Keyatala Pumping Station (The Works) and the principal quantities involved, but not limited to, are:

4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
- Average Annual Construction Turnover (AACT) for the last three (3) financial Years: equal to or more than INR 820.00 million
 - Experience in completion of at least one (1) similar type of the following works with a contract value of INR 860.00 million, in the last seven (7) years, before the date of bid submission: *{OR Experience in completion of at least two (2) similar types of the following works with a contract value of INR 430.00 million, in the last seven (7) years, before the date of bid submission:}*
 - Supply and laying of RCC/DWC pipe of size 400 mm and above – 1.7 km.
 - CC TV Survey work of assorted dia of RCC sewer of 1.7 km
 - Road restoration work for 3600 sqm.
 - Construction of one Pumping station including Pumpsets
 - Operation & maintenance of Sewerage / Drainage Pumping station
 - Must demonstrate availability of financial resources (less its financial obligations for current contract commitments), meets or exceeds the total requirement for the subject contract, as detailed below:
 - Sole Bidder: INR 102.50 million
 - For JV: One Partner must meet or exceed INR 40 million
 - For JV: Each Partner must meet or exceed INR 25 million
 - The combined financial resources of the Joint Venture must meet or exceed the total requirement for the Subject Contract of INR 102.50 million.
